Miniature Watercolor Show

March 3 thru March 26, 2010

Our miniature show, to be held in March, will be a juried show, but will not have winning placements or prizes. This spring show replaces the spring shows which were previously held at the Philbrook Museum.

You may enter up to 3 paintings, with a non refundable fee of \$10.00, which covers 1, 2, or 3 entered paintings.

GCWS reserves the right to reject any painting.

Show criteria:

Artist must be a member of GCWS in good standing.

Art work must be aqueous medium on watercolor paper.

No collage, glitter, or "glitzy" additions will be accepted.

All work must be original, i.e. not created in workshops, or under direct instruction, nor based on photography by anyone other than the artist.

All paintings must be priced for sale (do not enter any NFS paintings) Sales will be handled by gallery owner, David Wolf. A 30% commission will be taken by the gallery, of which 10% will be donated to the GCWS scholarship fund. Please price paintings to account for the commission.

Presentation and conditions:

Image size no larger than 10 inches in any direction

Image size no smaller than 2 inches in any direction

Frame size - outer edge no larger than 16 inch in any direction

Mats - for this show only may be any color, double, floating, or even no mat at all

Gallery standards:

Mats must be totally free of smudges, marks, flecks, and bits of foreign matter

Glass (including plexi) must be clean, both on the surface, and on the inside toward the painting

Frames must be sturdy, scratch and dent free, clean, and have tight corners

Wooden frames must have back dust covers

Metal frames must have foam core board or clean mat board backs

Hangers must be picture wire only, and be tight

Official identifying labels must be attached to upper left hand corner of back of painting

Conditions:

Delivery of all paintings, by hand must be done in the assigned time:

Last names A - L from 10:00 am to 10:45 am

Last names M - Z from 10:45 am to 11:30 am

Pick up of paintings not juried into the show may be done by returning to the gallery after jurying is complete or by allowing GCWS show coordinators to bring them to the general meeting on March 11 for pick up.

No replacements or additions of paintings after entry form is turned in

No replacements or additions of paintings after acceptance by jury into the show

All paintings must remain hanging for the entire duration of the exhibition

Important dates:

February 11, 2010 Entry forms and \$10 fee due. (this is the February meeting date)

March 2, 2010 Hand delivery of paintings to "A Gallery of the Arts"

Last names A - L, 10:00 - 10:45 am

Last names M - Z 10:45 - 11:30 am

March 3, 2010 Exhibition opens

March 13, 2010 Reception at the gallery from 2 - 4 pm

March 26, 2010 Pick up paintings from gallery from 2 - 4 pm
